

## **Executive Summary**

International Centre for Climate Change and Development (ICCCAD) is a climate change and environmental research related organization. In ICCCAD along with climate change there are many different programs, and these programs have different activities, but all of their main focus is climate change. ICCCAD mainly focuses on international or global problems. Capacity strengthening of multi-actors to limit climate change impacts and enhance resilience (CAP-RES) project aims to build resilience of multi-actors through capacity building at local level.

During my internship at CAP-RES project in ICCCAD, I worked with Management Department. I was involved in various responsibilities related to organizational and administrative tasks. I assisted with the development of a communication strategy, wrote blog posts, and conducted research. I also had the opportunity to attend various meetings and workshop that supported me to think broadly and increased my knowledge. Overall, my internship was a valuable learning experience that allowed me to develop new skills and gain practical experience in the field of research.

Conducting an assessment of the implications and vulnerability to climate change was one of the main areas I paid attention to. This involves examining climatic data, researching how climate change is affecting various areas and sectors, and determining how vulnerable communities and ecosystems are. Through this study, I was better able to comprehend the difficulties caused by climate change and the requirement for successful adaptation and resilience solutions.

### Introduction

I was excited to have this opportunity to do internship at ICCCAD, a leader in the field of climate change-based research. My primary responsibilities were to assist the management team with CAP-RES projects and learn as much as I could from them. I have conducted research to understand the current and future impacts of climate change on different regions, sectors, and communities. This involved analyzing climate data, assessing vulnerability and adaptation measures, and identifying priority areas for action. As a research intern in the International Centre for Climate Change and Development (ICCCAD) under the Capacity Strengthening of Multi-Actors to Limit Climate Change Impacts and Enhance Resilience (CAP-RES) project, I was involved in conducting research and analysis related to climate change and its impacts on various sectors. Here are some potential areas of focus for my internship:

## **About the Organisation**

ICCCAD is an climate research institute established in 2009. ICCCAD is one of Bangladesh's top institutions for doing research and creating capacity in the fields of development and climate change. The mission of ICCCAD is to gain and distribute knowledge on Climate Change and specifically adaptation and thereby helping people to adapt to Climate Change with a focus on the global South. It aims to build and lead a network of Southern-based partner institutes to providing education on climate change, adaptation and resilience. Bangladesh is at the frontline for finding ways to adapt to climate variability and risks. Innovative actions on climate adaptation are taking place at many levels, including those involving national government, sectoral agencies, NGOs and communities. Bangladesh is becoming a "living laboratory" on adaptation to climate change. ICCCAD is intended to build capacity among stakeholders in Bangladesh, while also enabling people from other countries to benefit from training in Bangladesh, where they can gain direct knowledge of issues in a real-world context.

## **Internship Objectives**

- The internship objective was to build capacity by using the ICCCAD in-house research programme
- · Conduct research on the issues related to climate induced L&D and LLA
- · Produce some knowledge products like research articles, policy briefs, blog articles etc
- · To assist in the planning, execution, and monitoring of the CAP-RES project
- Gain hands on experience and develop skills in project management.

# Description of Duties and Responsibilities

As per the circular, the duties and responsibilities of my position as an intern were:

- · Assessing the project manager in planning and executing
- Conducted research and gathered data to support project tasks.
- Helped to create project timelines and schedules.
- Assisted with project documentation and communication.
- Participated in team meetings and provided updates on assigned tasks.
- Helped to identify and manage project risks and issues.
- · Assisted with the development and implementation of project deliverables.
- Supported the project manager in ensuring that projects are completed on time, within budget, and to the satisfaction of all stakeholders.

Based on these obligations and responsibilities, the particular tasks I undertook throughout my internship

#### · Support the Manager in Project Planning and Execution:

I supported the manager in his day-to-day activities which includes support in event management, reporting, documentation, budgeting, communication with the vendor, recruitment, representation of ICCCAD and CAP-RES at several meeting and workshop etc.

#### Support in recruitment process:

I also helped in the recruitment process where I mailed the recruits, prepared evaluation sheets, attendance sheet and collected their personal documents.

#### Support in budgeting and financial issues:

I supported the financial planning and budgeting activities, such as preparing budgets, tracking expenses, and making bills. I helped the project manager in preparing budgets and bills for internal meetings, office stationaries, budgeting for inception workshop and residential workshop.

#### · Support in documentation and communication:

- **a**) I collected and documented all the project related documents (report, concept note, budget, and other) in a common drive in TEAMS previously created by the manager and currently used as a documentation hub for the project.
- b) As a part of the management team, I was assigned to manage the official documents of the newly recruited CAP-RES staff. I collected all the documents from them and uploaded in a common platform along with the job circular, list of applicants, shortlisted candidates, answer script, evaluation sheet and offer letter.
- c) I helped the communication team for developing a draft for **Communication and Branding strategy** for CAP-RES project.

#### Support in Meeting and Event Management:

- a) Project Inception Workshop: I had a number of duties such as, developing event checklist, guestlist, stationary list, preparing bills, rapporteuring, preparing IUB VC's Speech, documenting and support in report writing.
- b) Internal Residential Workshop: Here I was involved in listing project management activities, preparing presentation slides, creating activity timeline etc. I also collected quotation and made separate budgets for the selected venues for Internal Residential Workshop.
- c) **Project Quarterly Meeting**: I attended the project quarterly meeting and took notes from the meeting.

#### · Support in reporting

- a) I supported in preparing reports and documenting for the inception workshop and residential workshop.
- b) I also helped in preparing meeting minutes for different **internal meetings** of CAP-RES project.

#### Research Works:

- a) Travel Blog on visiting Mongla: I wrote a blog on "Exploring the Heart of Mongla: Balur Math Slum and Signal Tower Slum" based on my first time visit to Mongla where I shared my experience in two slum areas: Balur Math and Signal Tower Colony. Through this blog, I hope to shed light on the often-overlooked aspects of slum life as their access to clean and safe drinking water poses a significant challenge for the residents and through this blog, I tried to inspire others to appreciate the strength and potential that lies within these communities. - b) Review article on non-economic loss and damage: This article was developed through a literature review, which mainly include the International Journal of Disaster Risk Science, Global Change Biology, Environmental Management etc. Climate change non-economic loss and damage refer to the negative impacts of climate change that cannot be remedied through financial compensation. These may include the loss of cultural heritage, the displacement of communities, and the destruction of ecosystems. The drafted article can be found <a href="https://example.com/here">here</a>
- c) Policy Brief on National Adaptation Plan: Here I have illustrated the causes and solutions provided by NAP (2023-2050) regarding climate change related Migration and Displacement. From NAP I have found that Bangladesh, with up to 19.9 million internal climate migrants by 2050, is likely to have almost half the projected internal climate migrants for the entire South Asia region. NAP has also given some possible solutions for the protection and enhanced resilience of climate migrants in their new settlements. The drafted article can be found here.

- d) Feature article on CAP-RES project for Climate Tribune: ICCCAD has a long-term experience of research work on capacity building, and advocacy on climate change and environmental issues for the vulnerable communities, in Bangladesh and other Least Developed Countries (LDCs). Based on this experience ICCCAD along with Independent University Bangladesh and the Swedish International Development Cooperation Agency (SIDA) have started the 4 years (2023-2026) project "Capacity strengthening of multi-actors to limit climate change impacts and enhance resilience (CAP-RES)" which acknowledges the urgent need to mitigate the effects of climate change while also preparing communities to withstand and adapt to its consequences. - e) Article on Causes, Challenges and Solutions for Migration of unidentified people in Bangladesh: Migration can be an effective way for people to bounce back from environmental shocks or to escape climatic stress. Migration can also, however, expose climate migrants to new risks, hazards, and vulnerabilities when reaching their new destinations. When people are forced to leave their homes due to climate-related reasons, they often become internally displaced persons or migrate to other regions, including urban areas.
